

# NOTICE INVITING EXPRESSION OF INTEREST (EOI) FOR PROVIDING SERVICES FOR HIRING OF VARIOUS TYPE OF VEHICLE ON MONTHLY RENTAL BASIS AT RAIGARH ENERGY GENERATION LIMITED, RAIGARH (CHHATTISGARH)

Raigarh Energy Generation Limited (hereinafter called the 'Employer' / 'REGL'), a wholly owned subsidiary of Adani Power Limited, is operating and maintaining 1 x 600 MW coal based Thermal Power Plant located at Village: Chhote Bhandar, Post: Bade Bhandar, Tahsil: Pussore, District: Raigarh, Chhattisgarh, India (hereinafter called the 'Plant') is hereby inviting Expression of Interest (EOI) from interested and eligible parties for providing service for "Hiring of Vehicles (12 No's.) for a Period of Thirty Six (36) months i.e. from 01.04.2023 to 31.03.2026" for 1 x 660 MW Raigarh Thermal Power Plant, Village: Chhote Bhandar, Post: Bade Bhandar, Tahsil: Pussore, District: Raigarh, Chhattisgarh, India.

#### Annexure II - Scope of Work

The Scope of Works for Providing services for hiring of various passenger vehicles (12 nos.) for a period of Thirty Six (36) months i.e. from 01.04.2023 to 31.03.2026 for 1 x 600 MW Raigarh Thermal Power Plant, Village: Chhote Bhandar, Post Office: Bade Bhandar, Tehsil: Pussore, Raigarh, State: Chhattisgarh – 496100.

The detailed Scope as specified below:

- 1. Contractor shall provide a cost effective, comfortable, safe and secure transport system to Employer's Employees traveling to and from the office.
- 2. The vehicle shall be diesel operated and shall comply to Bharat Stage IV (BSIV) Emission norms and well equipped with air conditioning system, music system, luxurious interiors, neat and clean seat covers, air suspension, first aid box, air freshener spray, reverse camera & horn and all other accessories that are required to ensure comfort of employees of the Employer.
- 3. The vehicle must be maintained by the Contractor in good and sound working condition, regularly serviced, daily cleaned & freshened with perfumed air freshener, maintained and equipped with all mandatory safety requirements and fittings. Seats shall be always covered with neat and clean seat covers, the vehicle shall have good quality foot mat and good quality music system required to ensure comfort of the Employer's employees.
- 4. Contractor must deploy vehicle and services that are energy efficient, less polluting, environment friendly and have ecofriendly waste disposal mechanisms.
- 5. The vehicle shall be equipped with following specifications/ features:
  - a. Air Conditioning (AC)



- b. Tubeless tyres
- c. Neat and clean seat covers
- d. Music system.
- e. Provision of Mobile charger point for Passengers.
- f. Seat belt for every seat
- g. Fire extinguisher
- h. First Aid Box
- i. As per Bharat Stage IV (BSIV) Emission norms.
- j. GPRS tracking system in the vehicle.(Provided by Employer)
- k. Valid Fast Tag with adequate balance in Fast Tag
- I. Reverse Horn & Camera
- m. Vintage of Vehicle- Ageing of vehicles shall be less than 4 years and Permissible KM consideration shall be less than 2,00,000 KMs as on date of deployment of vehicles at site i.e. 01.04.2023.
- 6. The vehicle deployed by Contractor must be maintained in trouble-free working condition during the Contract Period. If the Vehicle go under breakdown, the Contractor shall provide immediate replacement of equivalent good quality vehicle without any additional cost to the Employer.
- 7. No Private Vehicle shall be allowed for making the alternate arrangements. If the Contractor fails to make the alternate arrangement, then the Employer reserves the right to make the alternate arrangement. The additional cost incurred by the Employer towards making such alternate arrangement (at actuals) along with applicable penalties shall be recovered from the Contractor's monthly RA bills.
- 8. The vehicle shall be deployed on all calendar days of the month including Sundays and holidays during the Contract Period on 12 & 24 hours/day basis as per the schedule prescribed by the Employer's OIC.
- 9. Requirement of Vehicles:
  - a. AC Innova: 3,000 KM/month/vehicle, 24 Hrs basis 01 No.
  - b. AC Innova: 2500 KM/month/vehicle, 24 Hrs basis 01 No.
  - c. AC Scorpio: 3,000 KM/month/vehicle, 12 Hrs. basis 02 Nos.
  - d. AC Scorpio: 5,000 KM/month/vehicle, 12 Hrs. basis 01 No.
  - e. AC Scorpio: 5,000 KM/month/vehicle, 24 Hrs. basis 04 Nos.
  - f. AC Bolero: 5,000 KM/month/vehicle, 24 Hrs. basis 01 No.
  - g. AC Bus (42 seater): 3,000 KM/month/vehicle, 12 Hrs. basis 01 No.
  - h. AC Tempo Traveller (26 seater): 10,000 KM/month/vehicle, 24 Hrs. basis 01 No.
- 10. Deployment of Driver for various passenger vehicles are as per below:
  - a. For 12 Hrs. /day working: 01 no. Driver.
  - b. For 24 Hrs. /day working: 02 nos. Drivers on rotation basis.

Deployment on 24 Hrs. basis with necessary arrangement of separate Driver for each shift in day & night time.

- 11. Driver shall always be available with the vehicle during the working hours.
- 12. Contractor shall supervise delivery of services and co-ordinate with Employer's admin representative on a daily basis for smooth functioning of its transport services, maintaining shift



- logbook, shift schedule, proper records of vehicles, gate pass formalities and Statutory compliances and for all kind of support.
- 13. Contractor shall ensure on-time arrivals of Employer's employee and shall establish a travel management system to ensure that the fleet is well kept and its statutory compliance fulfilled while utilizing the fleet to its optimal capacity.
- 14. Contractor must engage drivers with a proven performance track record and with no criminal record. The drivers must ensure proper behavior and maintain appropriate dress standards. Employer shall have the unquestionable right to request the Contractor to replace any staff whose performance, in its opinion, is found unsatisfactory, especially while performing duties for Employer.
- 15. Drivers shall not pick up any unauthorized passenger while performing duties for Employer.
- 16. Operation and function of vehicle and drivers shall be governed by Motor Vehicles Act/Motor Vehicles Rules and these shall be the responsibility of the Contractor. The vehicle must be Taxi Passing (Commercial vehicle) only.
- 17. Pick-up and drop points: A route is a path chosen by Employer's Admin representatives to bring Employer's Staff from chosen points in the **Raigarh city** to Employer's plant premises OR drop Employer's Staff from plant premises in the **Raigarh city** to chosen points.
- 18. All expenses incurred towards fuel, oil & lubricants, salaries of drivers, vehicle maintenance, insurance charges, RTO Tax, PUC charges, municipal taxes, license fees, registration charges and other charges are in the scope of the Contractor.
- 19. The chargeable KMs will be included from garage to garage up to 10 KMs only (i.e. a distance of up to 5 KMs between the garage to first pickup point or last drop point, is chargeable).
- 20. The base rate of diesel for monthly hiring charges and extra KM charges shall be Rs. 96.38/liter.
- 21. The unit rates (charges for monthly hiring, running KM and extra KM) shall remain firm during the tenure of the Contract period, except for revision in HSD price & RTO tax.
- 22. Any additional vehicle required during the year shall also be deployed on existing rate & terms and condition.
- 23. Fuel Price Increase/ Decrease: If diesel rate increases/ decreases w.r.t base rate (i.e. Rs. 96.38/liter.) financial implication shall be as per the below mentioned formula:

Financial Implication = Actual running KMs during the month (km) X Average change in diesel rate for the subject month w.r.t base rate (Rs./ltr.) / Mileage of Vehicle (km/ltr.)

- 24. Mileage of vehicles shall be considered as follows:
  - a. AC Innova 10 KM/Ltr.
  - b. AC Scorpio 11 KM/Ltr.
  - c. AC Bolero 11 KM/Ltr.
  - d. AC Tempo Traveller (26 Seater) 08 KM/Ltr.
  - e. AC Bus (42 Seater) 04 KM/Ltr.



If diesel price increases w.r.t base price (i.e. Rs. 96.38/Liter), the Contractor shall invoice for the resultant financial implication under separate head in their monthly RA bills. If diesel price decreases w.r.t base price (i.e. Rs. 96.38/Liter), the Employer shall deduct the resultant financial implication from monthly RA bills of the Contractor. Illustration for calculation of financial implication due to change in diesel price during the month shall be attached at Annexure-VI.

Contractor shall raise separate invoice along with supporting documentary evidence for reimbursement of additional expenses due to increase in HSD prices which shall be reimbursed under separate head after due certification by the Employer's OIC.

#### 25. GPRS tracking system in the vehicle:

- a. All vehicles should have GPRS tracking system and GPRS will be provided by Employer.
- b. Monthly total running Kilometers considered for billing based on the GPRS tracking system.
- c. Speed Limit will be cross checked with the GPSR tracking system for the violation of speed limit and penalty shall be applicable for violation of speed limit

#### 26. Contractor shall submit the monthly billing as mentioned below:

- a. Monthly Hiring charges for vehicle- Monthly Charges inclusive of hiring of vehicle with Driver and all expenses like fuel, lubricants, Mobil oil, maintenance charges, RTO passenger tax, other municipal taxes, license fees, registration charges, Salary of driver etc.
- b. Extra KM Charges: Extra KM Charges for particular category of vehicle shall be paid beyond cumulative running KM /month.

Extra KM charges shall be paid for extra distance covered over & above cumulative 6,000 KM for 02 nos. of AC Scorpio, 12 hr. basis (2 vehicles x 3000 km).

Extra KM charges shall be paid for extra distance covered over & above cumulative 15,000 KM for 03 nos. of AC Scorpio, 24 hr. basis (3 vehicles x 5000 km).

For other vehicles, extra KM charges shall be paid for extra distance covered over & above fixed KM/vehicle/month (applicable for 1 no. Scorpio 5,000 KM for Security; AC Innova 3,000 KM for Plant Head. and AC Tempo Traveller (26 Seater) 10,000 KM for Employees).

Extra KM not applicable for 01 No. AC Scorpio (12 Hrs, 5,000 km), AC Bolero (24 Hrs, 5,000 km) and AC Bus 42 Seater (12 Hrs, 3,000 km).

- 27. Toll Tax/charges & parking charges (wherever applicable) shall be reimbursed at actual against submission of documentary proof.
- 28. The Contractor shall comply with all the provision of Motor Vehicle Act/ Motor Vehicles Rules 1988 with latest amendments. The Contractor shall be responsible for meeting all statutory obligations with regards to registration of vehicles, road permit, route permit, comprehensive insurance, road tax, fitness certification of the vehicle etc. The Contractor shall also obtain permission for running the vehicle on hire/ contract basis from RTO. The vehicle shall always carry valid original documents i.e. driver's license, tourist permit, insurance papers, PUC, fitness certificate etc. The copies of all the papers shall be submitted by the Contractor to the Employer before commencement of the Contract.
- 29. The Contractor shall ensure that their drivers must always possess valid LCV license issued by RTO and should be fully familiar with the road, driving conditions and applicable highway codes.



- 30. The vehicle shall be driven as per the speed limit of Traffic Rules/Employer's Safety Dept. and as specified / notified by the RTO authorities from time to time. Parking of vehicle should be done as per the traffic rules Employer or its officials travelling by the vehicle provided by the Contractor will not at all responsible, if driver is penalized for such offence/s or caught for any antisocial or illegal acts of the driving.
- 31. The Contractor shall ensure that their staff deployed under the Contract are always in proper uniform (comprising of pant, shirt, shoes & name badge) as directed by the Employer's OIC and have good and courteous manners and drive the vehicles safely and shall have fair knowledge of Hindi language.
  - In the event of misbehavior of drivers (unsafe/ rash driving, unnecessary arguments, misconduct etc.), the Employer reserves the rights to expel the driver under intimation to the Contractor.
- 32. The Contractor shall be personally liable for the conduct, acts and safe driving by its staff. In all circumstances, the Contractor shall be liable to pay all damages, claims & costs arising on account of conduct or faulty driving by their drivers. The Contractor shall make good any loss / damage caused to the movable / immovable property of the Employer.
- 33. The center of operations of the all the vehicles shall be at "Raigarh Energy Generation Limited", 1 x 600 MW Thermal Power Plant. Vehicle will be based at Plant and **Raigarh** starting and end point will be Plant and **Raigarh**.
- 34. All statutory permissions regarding vehicles & staff deployed under the Contract and their operation shall be obtained by the Contractor. The Contractor shall be liable for all the liabilities arising out of their noncompliance of various statutory obligations as applicable.
- 35. All vehicle deployed by the Contractor shall have the display on the left side of windshield the word "ON DUTY- REGL".
- 36. The vehicle deployed by the Contractor shall be pollution free & display a valid 'Pollution under Control' certificate issued by Chhattisgarh Motor Vehicle Department.
- 37. The staff deployed by the Contractor shall not be employees of the Employer and shall not have any claim whatsoever on the Employer and shall not act detrimental to the interest of the Employer.
- 38. The Contractor shall be responsible for meeting all statutory obligations of their driver or their staff with regard to payment of salary/ wages, PF, ESIC/ workmen compensation etc. as provided under various applicable labour laws.
- 39. The Contractor shall arrange for accommodation and local conveyance of their staff at their own cost. No accommodation shall be provided in the Employer's premises for the drivers & cleaners, if any deployed by the Contractor.
- 40. The Contractor shall provide a log book in which their drivers shall correctly enter travel particulars such as departure time of vehicle from one point to another, time of arrival at destination, total kilometers covered for the journey etc. The log book with all the entries shall be submitted to the Employer's OIC on periodic basis/ on demand for verification & certification. Certified copy of the log book shall be submitted by the Contractor along with month RA bills at the end of every month.



In case, the signatures mentioned above are not obtained, such journey shall not be counted for the purpose of payment. If during any particular trip, it is noticed that the driver has not met the time schedule given to him or that he has caused inconvenience to the employees/passenger, applicable penalty shall be deducted from the Contractor's monthly RA bills.

41. Uniform: Contractor shall provide 2 pairs of uniform which includes pant & shirt as approved by Employer. Contractor has to ensure that deployed employees are wearing uniform properly & regularly during the duty hours. (I.e. proper uniform in good condition properly pressed & well-dressed condition).

#### Specific Agree Terms:

#### 1. Insurance:

The Contractor shall at its own expense, obtain all applicable insurances without any additional cost implication to the Employer such as

#### (a) Workmen Compensation (WC) policy/ ESIC as per prevailing laws,

- i. The Contractor and their Sub-contractors shall effect and maintain a Workmen's Compensation/ ESIC insurance (as applicable for Contractor's manpower) in compliance of the provisions of the Workmen Compensation Act/ ESIC Act, against liability for claims, damages, losses and expenses (including legal fees and expenses) arising from injury, sickness, disease or death of any Manpower of Contractor and/or Subcontractor or their representatives.
- ii. The insurance shall be maintained in full force and effect during the whole time that the Manpower is assisting in the execution of the Services. For a Sub-contractor's employees, the insurance may be affected by the Sub-contractor, but the Contractor shall be responsible for compliance with this Clause. In no event shall the Employer be responsible or liable for the payment of compensation to any Contractor's Personnel or Subcontractor's Personnel. Employer shall have the right to recover/adjust or set-off the amount of compensation, if any, paid by the Employer as a result of the failure of the Contractor to comply the conditions of the Workmen Compensation Act/ ESIC Act from all current and future amounts due and payable by the Employer to the Contractor.
- iii. The sum insured under the policy should be as per the provisions of the Workmen Compensation Act/ ESIC Act.

#### (b) Automobile Insurance:

i. The Contractor and their Sub-contractor shall effect and maintain at all times during the currency of the Contract, a comprehensive automobile insurance policy including Third Party Liability, for all vehicles plying in connection with the execution of Contract. Such automobile insurance policy shall be in compliance of the provisions of The Motor Vehicles Act, 1988. In no case shall the Employer be liable for any accident or third party property damage/ personal injury caused by any vehicle owned by Contractor and/ or Sub-contractor. Further, in no case shall the Employer be liable for non-compliance, of any statutory provisions of The Motor Vehicles Act, committed by the Contractor and Sub-contractor.



- ii. The Contractor shall also prescribe for add-ons in the Automobile Insurance policy for personal accident to be paid to drivers, cleaners & conductors, legal liability to driver, employees of Contractor travelling etc.
- iii. The value for insurance should be the IDV of the respective vehicle, as defined in the Motor Vehicle Tariff.

#### (c) Insurance for Tools and Tackles & Property (if applicable):

i. The Contractor and their Sub-contractors shall effect and maintain at all times during the currency of Contract an All Risks insurance policy covering their Tools and Tackles & property including furniture, fixtures etc. against all risks including but not limited to Fire, Explosion, Theft, burglary, breakdowns. Natural calamities etc.

The policy shall be on Reinstatement value basis and will have relevant add-ons like Costs of demolition, removal of debris, Employer/ Employer's surrounding property, Third party liability etc.

- ii. The Contractor and/ or Sub-contractor shall effect and maintain a Construction Plant & Machinery (CPM) policy covering all mobile equipment like earth moving equipment, cranes etc. against all risks including but not limited to Fire, Explosion, Theft, burglary, breakdowns, Natural calamities etc. The policy shall be extended to cover Third Party Liability under the policy. In case any or all such equipment are registered by RTO, in addition to a CPM policy, a Third Party Liability Motor policy in compliance of the provisions of the Indian Motor Vehicle act shall be taken.
- iii. The policy shall be on Reinstatement value basis and will have relevant add-ons like Removal of debris, Employer's Surrounding property, third party liability etc.
- 2. During the Service Order period, if the labour cost or any of the material price increases, then the responsibility lies with the Contractor to carry out the job at the awarded value without having any extra financial implication to Employer.
- 3. The contractor shall pay the wages & bonus to their drivers as per the minimum wages prescribed by Govt. of Chhattisgarh (GOC) for Public Motor Transport Industry during the Contract Period.
- 4. Lodging, boarding, transportation, conveyance etc. for the Contractor's drivers and staff shall be in the Contractor's scope.
- 5. Safety shoes, helmets and uniform for all the drivers/ staff shall be provided by the Contractor at their own cost.
- The Contractor shall ensure that availability of vehicles should be on 24 hours basis or as specified in the Contract. However, the vehicles shall be provided/ deployed as per the Employer's requirement.
- 7. The Contractor shall submit the vehicle's preventive maintenance record on monthly basis along with the monthly running account (RA) bill. The vehicles deployed by the Contractor must be maintained trouble free during the Contract Period.
- 8. The Contractor shall ensure that requisite documents i.e. Registration documents, License, permits, insurance; P.U.C etc. are always available with the driver. The copies of all the papers must be submitted to the Employer before commencement of the Contract.



- 9. The vehicle will be allowed for servicing against replacement of that vehicle once in a month. However, the Contractor shall take prior permission from the Employer's OIC for taking the vehicle out of service.
- 10. Contractor shall execute services as per the instruction / direction by the Officer in charge/ Employer's Representative.
  - While taking out the vehicle for maintenance purpose or any other specific purpose, the closing meter reading should be logged by the Employer's OIC and the KMs run for such purpose will not be payable by the Employer.
- 11. As and when required, the vehicles can be utilized for departmental picnic and other purposes in vicinity of Raigarh covering an area of 150 km (one way, say up to Raipur) as per the directive of Employer's OIC, but not more than Two (02) times in a month per vehicle. Additional expense towards RTO permit, toll taxes and other statutory charges, as applicable, will be paid by the Contractor during operation & the same shall be reimbursed through RA Bills.
- 12. The Contractor shall provide mobile phones to their drivers for better communication on duty with the Employer's OIC.
- 13. The Contractor shall provide the list of drivers and reliever drivers to the Employer's OIC before execution of the Contract and shall prepare their gate passes for the Contract Period. Only listed drivers will be permitted by the Employer to run the hired vehicles during the Contract Period.
- 14. Contractor should submit Form IV/ Form II (As per CL (R&A) Act) to the Human Resource (HR)/ Industrial relations (IR)/ Techno-Commercial (TC) Department.
- 15. All the labour laws & statutory compliances should be under the scope of Contractor. Contractors will be responsible to maintain all the required statutory records.
- 16. Contractor should be penalized for any violation of statutory compliances or code of conduct of the company.
- 17. Contractors must ensure safety training & provision of PPE to the Service Order labour.
- 18. Contractor will be responsible to initiate proper disciplinary action against his workers who are found indulging in subversive behavior or found violating the rules & regulations of work practices & discipline.
- 19. All the required training to Service Order labour will remain under the scope of the Contractor.
- 20. Any act of unlawful nature like illegal stoppage of work or strike, raising unreasonable demands, indulging in an act of violence will be managed strictly by the concerned Contractor.
- 21. Environmental Compliance:
- i. The Contractor shall perform the Services in a manner that gives appropriate regard to the protection of the natural environment.
- ii. The Contractor shall comply with all Statutory & Regulatory requirements and codes of practices relating to the products and services being offered as may be relevant.
- iii. The Contractor shall follow all Environmental Operational Controls while carrying out the activities within Employers premises as per the instruction by user dept.



- iv. here practicable, Contractor must use environmental friendly packing material for packaging.
- v. Contractor must not use any plastic material for packaging of any Equipment/Material being sent to our premises. Instead, we suggest you to use brown paper or any other alternate packaging material that is environment friendly (compared to plastic) provided it is NOT impacting the quality, safety, hygiene, life expectancy, throughput, performance, and minimum expected level of services. In case you are supplying the product/equipment/material in plastic packing, you shall abide and adhere by the Plastic Waste (Management and Handling) Rules. Plastic sheet or like, which is not an integral part of multi layered packaging and cover made of plastic sheet used for packaging, wrapping the commodity shall not be less than fifty (50) microns in thickness, except where the thickness of such plastic sheets impair the functionality of the product. In case of any deviation being sought, approval shall have to be taken from Employer prior to dispatch of material. This is a mandatory requirement and any non-compliance, may lead to material rejection.

#### 22. Energy Management Compliance:

- i. The Seller shall use energy efficient plant, tools and machineries for performing the work and related activities and execute the work in such a manner so as to optimize the energy consumption.
- ii. The Seller shall comply with all the Statutory & Regulatory requirements and codes of practices, as may be relevant for Energy Efficiency and conservation, relating to the products and services being offered.
